This is in continuation of our earlier circular dated 04.09.2023 regarding installation of Automated Boom Barrier System at the Society main gate.

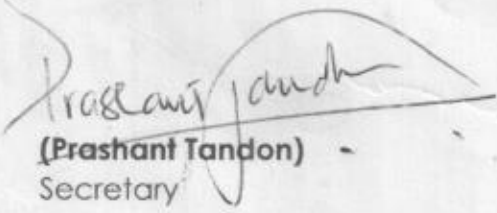
We are enclosing guidelines on how to register your vehicle in the Mobile app. A video link is also there to watch how to register. A link is also provided from where you can download the app. You can also download the app from App Store/ Play Store both for iOS and Android versions. A screen shot is attached for your reference.

After entering all the details, you have to upload the RC of your vehicle under Document Tab in the App. After that you have to generate a request for permission from Management. Then Management will approve the request after verification of all the details.

We are also enclosing the Society circular dated 22.05.2022 regarding car parking inside the society. All the requests of residents will be approved by Management based on this circular.

Subject: Automatic Boom Barrier System at Main Gate

Dear Residents,

The Society is going to install ABBS (Automatic Boom Barrier System) at the Society entry gate. The entry & exit of the cars/ two wheelers will be regulated by the system by reading the Fastags fixed on the windshield of the cars and RFID tag on two wheelers. The followings may please be noted:

1. All the residents are requested to please ensure they have Fastags on their cars. The Vendor will charge Rs 17.70 as Fastags integration charges.
2. Those residents who have more than two cars are requested to please inform the Society Manager, which two cars' Fastags to be integrated with the system as only two cars are allowed to park in the Society. The third car is allowed only as a guest car (charges applicable for guest cars as per Society rules).
3. For Guest/ visitors parking first, Guard will confirm from the residents then issue one slip from the POS machine & open the gate. While going out, the Guest/ visitor will return the slip to guard after that the gate will open.
4. For Two Wheelers (Scooters/ Motorcycles etc.) the operator will provide RFID tags to regulate the entry & exit. The cost of RFID tag is Rs 59/-, which will be charged from the residents. All the residents are requested to please inform the Society Manager about the Registration number of Two Wheelers so that sufficient number of tags can be procured.
5. The entry & exit of cars of the Tenants will be regulated as per period of rent agreements available in the Society records. All the tenants are requested to please update the rent agreement in the Society office. Only one (1) car is allowed for tenants as per Society rules.
6. The Society can take out the details of all the cars (residents/ visitors) daily, weekly or monthly basis, from which it can be checked that how many hours/ days the vehicle remained inside the Society.
7. All the residents are requested to please keep patience in the beginning as the system will take few days to be integrated properly. System is expected to be in operation from the end of September 2023.
8. A Mobile application will be installed in your mobiles through which you can see or control the entry & exit of your car/ two wheelers.

The Society will circulate the guidelines, benefits, features etc. shortly.
