NOTICE FOR CAR/TWO WHEELER PARKING

We reiterate below the gist of various notices issued from time in respect of the above subject for strict compliance:

| <u>Category of resident</u> | <u>No. of cars which could be parked in society</u> | <u>Procedure to be followed for parking EXTRA car</u> |

| <u>SUBJECT TO AVAILABILITY OF SPACE</u> | | |
| Flat owners | 2 | On applying on prescribed form and after being permitted <u>3rd car</u> will be allowed to be parked in the Society for 3 Days on payment of parking charges of <u>Rs.100/- per day</u> . If not removed within 3 days, penal parking charge of <u>Rs.1,000/- per day</u> will be charged from 4 th day. |
| Tenants | 1 | The above procedure is applicable for parking 2 nd car. <u>3rd car NOT allowed.</u> |
| Relative/visitor's car | Nil | On applying and on being permitted one car will be allowed entry in the Society for parking free of charge for 2 days per flat per month. On being allowed, it could be parked for 3 more days for which <u>Rs.100/- per day</u> will be charged. If not removed within 5 days, from 6 th day, penal parking charge of <u>Rs.1000/- per day</u> will be charged through monthly maintenance charges bill. |

NOTE – Swapping of car against eligibility of flat owners/tenants not allowed.

NO CAR TO BE PARKED AT ENTRANCE OF BASEMENT PARKING OR AT THE MAIN GATE INSIDE OR AT PASSAGE.

Forms for applying for parking extra car are with guard at main gate and at Society's office.

Two wheelers – TO BE PARKED ONLY AT SPECIFIED PLACES IN BASEMENT/ BACKSIDE OF D.BLOCK AT ALL TIMES FREE OF CHARGE.

IF FOUND PARKED AT ANY OTHER PLACE IN SOCIETY AT ANY TIME DURING THE DAY OR NIGHT, PENAL CHARGE OF RS.10/- PER DAY FOR A MAXIMUM OF 10 DAYS. IF PARKING CONTINUES AFTER 10 DAYS ALSO, RS.50/-PER DAY.

CARS/TWO WHEELERS WITHOUT STICKER WILL NOT BE ALLOWED ENTRY IN THE SOCIETY. STICKERS SHOULD BE OBTAINED FROM SOCIETY'S OFFICE BY PRODUCING OWNER'S/TENANT'S R.C.BOOK COPY BY 20.9.2017.

The above charges/penal charges will be strictly enforced from 16.09.2017.
