The contents of our above Notice are reproduced herewith for following the instructions/advises mentioned therein.

The residents are again requested to advise the drivers to follow the instructions properly about the contents of the Notice and instruct the drivers to follow them properly. The drivers who have submitted driving license and copy of photograph are not required to submit the same again.


CONTENTS OF OUR NOTICE DATED 20.6.2018

"WITH A VIEW TO HAVE A CHECK AND CONTROL ENTRY OF UNAUTHORISED PERSONS IN THE SOCIETY, THE RESIDENTS WHO HAVE EMPLOYED DRIVERS FOR THEIR CARS ARE REQUESTED TO ADVISE THEIR DRIVERS TO SUBMIT A COPY OF THEIR DRIVING LICENCE AND ONE COPY OF PASSPORT SIZE PHOTOGRAPH WITH THE SOCIETY BETWEEN 11.30 A.M. TO 6.30 P.M. TO ENABLE THE SOCIETY TO ISSUE THEM SOCIETY'S ID CARD TO FACILITATE ENTRY INTO THE SOCIETY.

WE TRUST, THE CONCERNED RESIDENTS HAVE WITH THEM THE POLICE VERIFICATION REPORT OF THE DRIVERS. IF IT IS NOT DONE, THEY MAY PLEASE ARRANGE FOR THE SAME IMMEDIATELY.

THE CONCERNED RESIDENTS ARE ALSO REQUESTED TO ADVISE THEIR DRIVERS THE FOLLOWING :

1. THE TWO WHEELERS/CYCLES OR ANY OTHER VEHICLE USED FOR THEMSELVES BY THE DRIVERS SHOULD NOT BE PARKED INSIDE THE SOCIETY. THE VEHICLES PARKED OUTSIDE THE SOCIETY ARE AT OWNER'S RISK.
2. THE PLACE PROVIDED NEAR THE 2ND GATE OF SOCIETY SHOULD BE USED BY THE DRIVERS DURING THEIR LEISURE TIME. NO OTHER PLACE INCLUDING THE GUARD ROOM SHOULD BE USED FOR SITTING.
3. THE SERVICES OF GUARDS SHOULD NOT BE USED BY THE DRIVERS FOR ANY TYPE OF WORK INCLUDING SENDING THEM TO THE MARKET TO BRING TEA/EATABLES."
